Please make sure that you and/or your contractor (if applicable) read **ALL INFORMATION** including the covenants and restrictions. This is imperative since **YOU** are responsible for your contractors work during the building process.

After your plans have been submitted to the ACC Sub-Committee you will be notified if any changes are required before starting work. Please remember that you must have final approval from the ACC Sub-Committee before **ANY** work can begin on your property.

Deadline for submission is <u>12:00 noon on the first Thursday of each month</u>. Please submit all plans before this time if you wish them to be considered for approval. You will be notified of approval or denial within 30 days of the date submitted.

Please observe the following stipulations when making modifications to the exterior of your home:

- 1. No sub-contractor signs may be placed on site.
- 2. Silt fencing must be installed on perimeters where the ground has been disturbed. If you do not install this, we will contact someone who will at the HOMEOWNER'S EXPENSE (usually the charge for this will be excessive).
- 3. If there are any modifications to submitted plans to the exterior of the home after the original plan is submitted it is the responsibility of the homeowner to notify the ACC.
- 4. Please keep construction traffic on the home site and not parked in the road or on any adjoining lot. Any tracks, roads, or disturbed lot adjacent will result in the homeowner having to place the lot in original condition at their expense.

ARCHITECTURAL CONTROL SET BACKS

REAR: 50 FT. FROM PROPERTY LINE AND NOT WITHIN THE FLOOD PLAIN FOR LOTS LOCATED ON LAKES (HOME OWNER IS RESPONSIBLE FOR VERIFICATION)

<u>FRONT</u>: 40 FT. FROM PROPERTY LINE (PROPERTY LINE IS APPROX. 13 FT. FROM ROAD -TOTAL OF 53 FT. FROM ROAD)

SIDE: 20 FT. FOR EACH SIDE

NOTE: ALL THESE SETBACKS MAY NOT APPLY TO THE GABLES, ST. ANDREWS, FOXCHASE OR LOTS ALONG RIVER'S RUN. THESE AREAS HAVE SEPARATE SETBACKS.
